May kindly see the online application of Smt. Bharti Tayal, Additional Civil Judge, (Junior Division), Bulandshahar regarding permission to sell her old Toyota Etios car.

In her application, Smt. Bharti Tayal has stated that she intends to sell her Toyota Etios car bearing reg. no. HR51AQ4024. Copy of registration can be seen as attachment. This car is proposed to be sold to Sri Naresh S/o Sri Prakash R/o H. No. D A-290. Ward No.-01, Near BN Model School, Prakash Vihar, Palwal-121102, Haryana for a sum of Rs. 1,28,000/-. She has further stated that the proposed purchaser is neither related to her and nor any case of the purchaser is pending in her court. She has, therefore, requested to place her application before the Hon'ble Court for grant of permission to sell her aforementioned car to the proposed purchaser.

In this connection it is submitted that the car had been purchased by the officer before her joining of judicial service, as appears in the Property Statement submitted by the officer (Old case ID no. 2890). The relevant Rule 24(2) of the U.P. Government Servant's Conduct Rules-1956, applicable in this case, is reproduced as below: -

"A Government servant who enters into any such transaction concerning any movable property exceeding in value the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority.

Provided that no Government servant shall enter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Bulandshahar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956, for the district Bulandshahar for His Lordship's kind persual and if His Lordship approves, Smt. Bharti Tayal, Additional Civil Judge, (Junior Division), Bulandshahar be granted permission to sell her old Toyota Etios car, bearing registration no. HR51AQ4024 to Sri Naresh S/o Sri Prakash R/o H. No. D A-290. Ward No.-01, Near BN Model School, Prakash Vihar, Palwal-121102, Haryana for a sum of Rs. 1,28,000/-, as requested, subject to the condition that the relevant papers in connection with the sale transaction shall be furnished immediately on completion of the transaction?
