May kindly see the online requisition dated 26.06.2023 of Sri Pushpendra Kumar Singh, Civil Judge (Junior Division), Rasra, Ballia, requesting for inclusion of LL.M. qualification in his service records vide Case Id No. S00004052021. In view of the above, Sri Pushpendra Kumar Singh, has furnished his duly attested scanned copies of LL.M. Mark-sheets of all four semesters and of the Degree Qualification, as supporting documents for the same.

In connection with the above, it is submitted that Sri Pushpendra Kumar Singh, joined the U.P. Judicial Service on 16.11.2019, initially as Additional Civil Judge (Junior Division), Agra. Further, it is relevant to mention here that Sri Pushpendra Kumar Singh pursued his LL.M. two-year degree course from Aligarh Muslim University, Aligarh, U.P., in the year 2017-2019, prior to joining the Judicial Service.

In addition to the above, as evident from submitted attested copy of LL.M mark-sheets (all four semesters) and the copy of Degree Qualification, Sri Pushpendra Kumar Singh, completed his two-year LL.M. degree course in the year 2019 and was subsequently awarded the LL.M. Degree from Aligarh Muslim University, Aligarh, U.P, on 22.02.2020, thus, the said qualification may be included in his service records, as is prayed for.

Further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Pushpendra Kumar Singh, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 26.06.2023 of Sri Pushpendra Kumar Singh, Civil Judge(Junior Division), Rasra, Ballia to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Ballia, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (all four semesters) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Pushpendra Kumar Singh, Civil Judge(Junior Division), Rasra Ballia may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter relating to inclusion of LL.M. Degree in service records.
