May kindly see the online application of Smt. Mita Singh, the then Additional District & Sessions Judge, Mainpuri presently posted as Special Judge (E.C. Act), Mainpuri by which she has requested for grant of permission to purchase a 0.32 bore Revolver MK-IV.

In her application, Smt. Mita Singh has stated that she is an armed licence holder and wants to purchase a revolver/pistol for self-defence. Thus, she wants to purchase a 0.32 Revolver MK-IV from Small Arms Factory, Kanpur. The cost of the said firearm shown on Small Arms Factory, Kanpur website is Rs. 98,560/-, source of which is her salary savings (copy of licence and passbook can be seen as attachment). Furthermore, the officer was also asked to clarify that her name in Arm's Licence No. 2780 / T.G.S. Gonda dated 08.03.2021 is mentioned as "Mita Singh" however in service records her name is mentioned as "Mita kumari". In reply of the same, she has stated that after her marriage her surname has been changed as Mita Singh. She has applied for change of her name as Mita Singh in place of Mita Kumari in service records. Copy of 'Letter' & 'Officer Memorandum' can be seen as attachment. Her request to change her name has been approved by competent Authority. Therefore, she has requested that her application may kindly be placed before the Hon'ble Court for grant of permission to purchase 0.32 bore Revolver MK-IV.

In this connection, it is submitted that according to this Court's C.L. no. 11/ IV-h-16/ Admin (A) dated 12.04.2010, the officer is required to take permission of this Court to purchase firearm, for which she has requested. Her request is considerable, as she has submitted sufficient details of the proposed transaction.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri for disposal of the matters of Judicial Officers, of information/ permission of sale/ purchase of movable/ immovable property or gift etc., for the District Mainpuri, for His Lordship's kind perusal and if His Lordship approves, Smt. Mita Singh, Special Judge (E.C. Act), Mainpuri be granted permission to purchase 0.32 Revolver MK-IV from Small Arms Factory, Kanpur, estimated cost of which is Rs. 98,560/- as requested, subject to the conditions that relevant papers of purchase transaction be submitted by her immediately after its completion?
