

## **Registrar (J) (Budget)**

May kindly see the online application of Sri Anshuman Yadav, presently posted as Registrar, Land Acqui, Rehab & Resettlement Authority, Varanasi who joined service on 29.11.2019, drawing gross salary of Rs. 84,388/- & take home salary of Rs. 79,188/- regarding information about purchase of a new Kia Seltos Htk (Diesel) car, allotted reg. no. UP 32 LU 8705, intimated through application dated 08.05.2021.

Through his application, Sri Anshuman Yadav has submitted information about purchase of a new car on 14.01.2021 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Nivan Balaji Automovers Pvt. Ltd., Gomti Nagar, Distt. Lucknow for Rs. 13,92,000/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 12,00,000/- is stated to have been taken as loan from Bank of Baroda, Faizabad, repayable in 84 monthly installments of Rs. 18,555/- (copy of 'loan arrangement letter' can be seen as attachment). (Further, the amount of Rs. 1,00,000/- transferred to his A/c in Bank of Baroda, Faizabad from his salary A/c in SBI, Faizabad). Thus, total amount of Rs. 13,00,000/- is stated to have been paid from BOB, Faizabad through RTGS, Rs. 42,000/- is stated to have been given by his father (Sri Janardhan Prasad Yadav) (copy of 'consent letter' can be seen as attachment), rest Rs. 50,000/- is stated to have been paid out of his own S.B. A/c (copy of statement of A/c can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Varanasi, for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
