May kindly see the online application received from Sri Satish Chandra Dwivedi, Spl. Judge (SC/ST, Pev. of Atroci. Act), Chitrakoot by which he has submitted supplementary details/ papers in connection with grant of permission to purchase a 32 bore Revolver (Prahar) in compliance of Hon'ble Court's order dated 20.07.2021.

In this connection, it is submitted that in his earlier application, Sri Satish Chandra Dwivedi has requested for grant of permission to purchase a 32 bore Revolver (Prahar) from Small Arms Factory, Kanpur for Rs. 1,05,037/- (with GST). The matter was submitted before Hon'ble Mr. Justice Om Prakash-VII, vide detailed office note dated 02.07.2021, upon which His Lordship had been pleased to order:

"Officer be directed to inform whether he owns any other fire arm or not and, if yes, provide details of the same."

The order was communicated online to the officer.

In reply of the Hon'ble Court's order, Sri Satish Chandra Dwivedi, has stated that he does not own any other fire arm.

As such, the matter is now required to be submitted again to Hon'ble Court for further order, as proposed in earlier office note dated 02.07.2021, by taking into consideration the present reply, as submitted by the officer in compliance of Hon'ble Court's order/query.

It is also submitted that earlier the matter has been submitted before Hon'ble Mr. Justice Om Prakash-VII, Nominated Judge for the purpose vide office note dated 24.07.2021, but the same has been returned due to change of nomination and it is now likely to be submitted before Hon'ble the Administrative Judge concerned as per the order of nomination passed by Hon'ble The Chief Justice vide order dated 28.10.2021.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Chitrakoot, also nominated for "Disposal of the matters of Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Chitrakoot, for His Lordship's kind perusal & if His Lordship's approves, permission be granted to Sri Satish Chandra Dwivedi, Spl. Judge (SC/ST, Pev. of Atroci Act), Chitrakoot to purchase 32 bore Revolver (Prahar) from Small Arms Factory, Kanpur, estimated cost of which is Rs. 1,05,037/- (with GST) as requested, subject to the conditions that relevant papers of purchase transaction be submitted by him immediately after its completion?
