The relevant rule relating to gift (Rule 11 of the U.P. Government Servant's Conduct (Amendment) Rules, 1998) and relating to transfer of immovable property [Rule-24 (1) of U.P. Government Servant's conduct Rule-1956] runs as under: -

11. Gifts:- A government servant shall not without previous approval of Government :-(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or

(b) Permit any member of his family who is dependent on him, to accept Any gift, gratuity or reward from any person other than a close relative.

In view of the above, the information so submitted by the officer is likely to be acceptable, as the car has been gifted to her by her father, which is the closest blood relative.

In this connection it is submitted that the Rule-24 (2) of U.P. Government Servants Conduct (Amendment) Rules, 1998 relating to transfer of such item, is as follows: -

"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Bijnor also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Bijnor for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
