May kindly see the online application of Sushri Aroma Raman Picess, Additional Civil Judge (Junior Division), Gonda who joined service on 14.11.2019, drawing gross salary of Rs. 84,355/-& take home salary of Rs. 71,675/- regarding information about purchase of new Hyundai CRETA SX 1.5 car, allotted reg. no. UP32 LR5351, intimated through application dated 17.06.2021.

Through her application, Sushri Aroma Raman Picess has submitted information about purchase of new car on 20.09.2020 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from JSV Motors and Cons. Pvt. Ltd., CP-3/10 Vijyant Khand, Gomti Nagar, Lucknow who is an authorised dealer, for Rs. 15,44,476/- (copy of 'invoice' can be seen as attachment), source of which is that Rs. 13,00,000/- has been taken as loan from SBI, Gonda repayable in 84 EMIs of Rs. 20,327/- (copy of 'loan arrangement letter' can be seen as attachment) & Rs. 5,00,000/- has been taken as personal loan from SBI, Gonda repayable in 72 EMIs of Rs. 9,415/- & the same is stated to have been paid through two cheques to the dealer. (Copy of 'loan arrangement letter' & cheques can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

The matter was previously submitted to Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Nominated Judge, through detailed office note dated 25.10.2021, placed above but as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted, thus the same got reverted without any order. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Gonda, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
