May kindly see the online application of Sri Bans Bahadur Yadav, presently posted as Presiding Officer, Commercial Court, Kanpur Nagar who, joined service on 25.09.1999, drawing gross salary of Rs. 1,85,769/- & take home salary of Rs. 1,44,369/- regarding information about purchase of a new Maruti XL6 Smart Hybrid Alpha car, intimated through application dtd. 23.06.2021.

Through his application, Sri Bans Bahadur Yadav has submitted information about purchase of a new car on 18.02.2021 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Fair Deal Cars Pvt. Ltd. (Nexa Noida) C-7, Sector-10, D.N.D. Road, GB Nagar, Noida who is an authorised dealer, for Rs. 12,36,004/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 10,00,000/- has been taken as loan from SBI, Mainpuri, repayable in 60 EMIs of Rs. 20,227/- (copy of loan arrangement letter can be seen as attachment), Rs. 21,004/- as booking amount through NEFT, Rs. 1,50,000/- through NEFT & Rs. 25,000/- through cheque no. 834452 are stated to have been paid out of his S.B. A/c no. 111472253969 (copy of statement of A/c can be seen as attachment) Rs. 40,000/- is stated to have been deducted from the cost price on account of exchange of his old Maruti Zen VXi car (copy of delivery receipt can be seen as attachment) & rest Rs. 2809/- for accessories has been provided by the dealer. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Kanpur Nagar, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
