

**Joint Registrar (J)(Budget)**

May kindly see instant online application dated 26.06.2021 of Smt. Priya, Addl. Civil Judge (Jr. Div.), Lucknow regarding addition of surname, i.e. 'Nagar' to her name in her service records, 'Smt. Priya' on account of her marriage to Sri Sunil Kumar Nagar.

In this matter, it is pertinent to mention here that an objection was raised on the said application on 19.07.2021 by this office, vide which Smt. Priya was requested to publish public notice regarding addition of her surname, in one State and Local Newspaper along-with an original affidavit in this regard, stating therein the relevant facts regarding addition of surname, as required in terms of provisions contained in G.O. No. 3497/III-500(5)-46 dated 06-11-1946.

Going further, on 20.08.2021, she has attached the required Newspapers cuttings after publishing notices regarding addition of surname, 'Nagar' to her name, 'Smt. Priya' in one state newspaper, i.e. Hindustan of Date 14.08.2021 and one local newspaper, i.e. Ayodhya Times of Date 05.08.2021, and the original affidavit in this regard along-with certificate of registration of her marriage. In addition to this, vide her letter dated 03.09.2021, bearing endorsement no.2383/I-P.F. Dated 04.09.2021, she has also submitted the same in original by post to this Hon'ble Court as requested vide the abovementioned objection.

It is further submitted that appointing authority of Judicial Officers of U.P. Nyayik Sewa is the Government of Uttar Pradesh. Therefore it seems proper that aforesaid application of Smt. Priya, Addl. Civil Judge (Jr. Div.), Lucknow, regarding addition of her surname, may be sent to the Government of U.P. for obtaining orders in this matter, in accordance of G.O. No. 3497/III-500(5)-46 dated 06-11-1946.

In the facts and circumstances as mentioned above, if approved by Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow, letter dated 03.09.2021 of Smt. Priya, Addl. Civil Judge (Jr. Div.), Lucknow, regarding addition of surname, 'Nagar' to her name, 'Smt. Priya' in her service records, original copies of Newspapers, containing the advertisements in this regard (two), original affidavit, copy of certificate of registration of marriage and attested photocopy of her application form of U.P. Nyayik Sewa, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow, for obtaining necessary orders of the Government in this matter?
