UP81CR2070, in exchange of her old Swift car, intimated through application dated 30.06.2021.

Through her application, Smt. Manisha has submitted information about purchase of a new car on 26.02.2021 by giving point wise details as per Court's C.L. no. 25/Admin(A) dated 13.07.1998, according to which the car has been purchased by her from M/s Mascot Speed India Pvt. Ltd., Mascot Estate, 5 kms. Delhi G.T. Road, Aligarh who is an authorized dealer, for Rs. 10,82,167/- in total (copy of invoice can be seen as attachment), source of money of which is that Rs. 9,40,000/- has been taken as loan from State Bank of India, Aligarh repayable in 84 EMIs of Rs. 14,581/- (copy of 'loan arrangement letter' can be seen as attachment), Rs. 500/-, Rs. 10500/- & Rs. 1,31,000/- are stated to have been paid to the dealer through NEFT out of her S.B. A/c, source of which are maturity amount of L.I.C. policy (copy of statement of A/c & receipts can be seen as attachment). It is pertinent to mention here that along with other charges & discounts, Rs. 25,000/- is stated to have been adjusted by the sale price of her old Swift car with the total price of the new car (copy of exchange certificate can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Etah, for His Lordship's kind perusal and information under Rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
