

Joint Registrar (Judicial)(Budget)

May kindly see the letter dated 27.06.2021 (uploaded online on 01.07.2021) of Sushri Saumya Arun, Additional Civil Judge (Junior Division), Varanasi, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 10502021 (Old Case Id 2084). In compliance of same, Sushri Saumya Arun furnished all her LL.M. credentials comprising LL.M. Mark-sheets of all the four semesters and copy of Degree for inclusion of her qualification in the service records.

In this connection, it is submitted that Sushri Saumya Arun, joined the U.P. Judicial Services on 16.12.2019, as Civil Judge (Junior Division), Varanasi. Besides, as evident from submitted attested copies of mark-sheet (four semesters) and degree of LL.M., Sushri Saumya Arun completed two years LL.M. course, for the academic session 2018-2020, and was subsequently awarded degree from Banaras Hindu University, Varanasi on 16.03.2021 for the examination year 2020, thus said qualification may be included in her service records.

It is pertinent to mention here that Admin A-4 section, through offline note, approved by the then Hon'ble Chief Justice dated 29.09.2020 and vide Hon'ble Court's letter no. 8708/IV-5133/Admin A-4 dated 06.10.2020 granted permission to concerned Judicial Officer to appear before fourth semester LL.M. examination conducted by Banaras Hindu University, Varanasi.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus said qualification of LL.M. Degree may be included in the service records of Sushri Saumya Arun, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 27.06.2021 (uploaded online on 01.07.2021) of Sushri Saumya Arun, Additional Civil Judge (Junior Division), Varanasi, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Varanasi, for kind perusal and order to the effect that a copy of her application along with copy of Mark-sheet (four semesters) and Degree of LL.M. (uploaded online on 01.07.2021) as well as attested copy of form of U.P. Nyayik Sewa of Sushri Saumya Arun, Additional Civil Judge (Junior Division), Varanasi, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
