A/c no. 30775219392 (copy of passbook can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

The matter was previously submitted to Hon'ble Mr. Justice Mohd. Faiz Alam Khan, Nominated Judge, through detailed office note dated 29.09.2021, placed above but the matter has been reverted back. Government Servants' Conduct Rules 1956" for the district Rampur, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
