

**Joint Registrar(J)(Budget)**

May kindly see letter dated 01.07.2021 (uploaded online on 05.07.2021 at SL No. 01) along-with attested copies of mark-sheets (both semesters) and degree of LL.M qualification (uploaded online on 05.07.2021 at SL No. 02 & 03) of Sushri Saumya Pandey, Judicial Magistrate Bhadohi at Gyanpur, requesting for inclusion of LL.M qualification in her service-records.

Sushri Saumya Pandey, aforesaid, has requested for inclusion of LL.M. Qualification in her service records vide her letter dated 01.07.2021 (At SL No. 01) and has uploaded attested copies of mark-sheets (both semesters) and Degree of LL.M. Qualification (At SL No. 02 & 03).

In this context, it is submitted that Sushri Saumya Pandey, aforesaid, joined U.P. Judicial Services on 15.11.2019 as Judicial Magistrate, Bhadohi at Gyanpur. Besides, as apparent from submitted attested copies of mark-sheets (both semesters) and degree of LL.M. qualification (at SL No. 02 & 03), Sushri Saumya Pandey, completed LL.M. course in year 2019 and was subsequently awarded Degree from Dr. Ram Manohar Lohia National Law University, Lucknow on 10.07.2019. Nevertheless, relevant details about course completion is not mentioned in her application form of U.P. Nyayik Sewa, thus, said qualification is required to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Saumya Pandey, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 01.07.2021 of Sushri Saumya Pandey, Judicial Magistrate Bhadohi at Gyanpur may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bhadohi at Gyanpur, for kind perusal and if His Lordship approves for order to the effect that copy of aforesaid letter dated 01.07.2021 (At SL No. 01) along with attested copies of mark-sheets (both semesters) and degree of LL.M. (At SL No. 02 & 03), as well as attested copy of form of U.P.Nyayik Sewa of Sushri Saumya Pandey, Judicial Magistrate Bhadohi at Gyanpur, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
