

**Joint Registrar (Judicial) (Budget)**

May kindly see the online application of Sri Yughul Shambhu, Judicial Magistrate, Etah who joined service on 01.10.2018, drawing gross salary of Rs. 91,113/- & take home salary of Rs. 78,708/- regarding information about purchase of new Hyundai Verna 1.6 VTVT SX (Petrol) car, allotted reg. no. UP13 BJ 4561, intimated through application dated 10.09.2021.

Through his application, Sri Yughul Shambhu has submitted information about purchase of new car on 19.06.2019 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Fortune Hyundai (Aspire Automobile Pvt. Ltd.), Khasra No. 571, Bhoor Crossing Delhi Road, Bulandshahr who is an authorised dealer, for Rs. 11,25,999/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 9,45,000/- has been taken as loan from State Bank of India, repayable in 84 installments of Rs. 15,397/- (copy of 'loan arrangement letter' can be seen as attachment) & rest Rs. 1,81,000/- (i.e. Rs. 10,000/- on 10.05.2019 through net banking & Rs. 1,71,000/- through RTGS on 20.06.2019) is stated to have been paid out of his own S.B. A/c no. 38005384944 (copy of statement of A/c be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The said office note dated 15.09.2021 was submitted before Hon'ble Mr. Justice Om Prakash-VII, upon which His Lordship has been pleased to order:-

**"Office to report as to whether officer has submitted property statement timely or not."**

In this connection, it is submitted that the officer has already submitted property statemet on case ID no. 1665 on 09.02.2021 for at the time of joining (joining date -01.10.2018) which was due, but belatedly, for which he has not submitted any reasons for delay.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Mohd. Faiz Alam Khan, Administrative Judge, Etah also nominated for "Disposal of the matters of Judicial Officers, wherein permission /information for sale or purchase of movable/ immovable property and permission/information to accept gift under U.P. Government Servants' Conduct Rules 1956", for His Lordship's kind perusal & further order in the matter of information about purchase of a new Hyundai Verna 1.6 VTVT SX (Petrol) car?
