May kindly see the online application of Sri Mayank Kumar Jain, District & Sessions Judge, Gonda regarding grant of permission to use official car for undertaking journey from Gonda to Balrampur for personal use.

In his online application dated 11.07.2021, Sri Mayank Kumar Jain has stated that he along with his family wants to go to the temple of Maa Devipatan for darshan. This temple is situated in Distt. Balrampur and is about 80 kms. from Gonda headquarter. He wants to use official car no. UP43 G0414 for this journey. He shall pay the charges as per rule. On asking him to mention the date of his journey, through his further communication dated 12.07.2021, he has further stated that inadvertently the date of journey, which was 11.07.2021, was omitted to be mentioned in his request. The journey was performed by him on 11.07.2021 in anticipation to the sanction by Hon'ble Court. The inconvenience is regretted. He has requested that Hon'ble Court may kindly be moved to accord him permission for the use of official vehicle for the above mentioned visit.

In this connection, It is submitted that the date for his visit from Gonda to Balrampur to visit the temple of Maa Devipatan for darshan has already passed over & in the meantime the journey has already been performed by the officer. He has used the official vehicle for his personal journey from Gonda to Balrampur, for which he had requested prior to perform journey, which is in accordance with rules/ G.O.

In this connection, it is submitted that there are G.O. no. 710/X Sa. Vi. Mit.-02-97 dated 29.05.1999 and another G.O. no. C.A. 1415/X-2002-Mit.-02/2001 dated 28.09.2002 issued for adopting economic measures in respect of admissibility and maintenance of Govt. vehicle in which certain directions were issued for adopting economic measures under the principle of "Value for money" for the Govt. vehicles as well as have certain directions that those officers who have been allotted a govt. vehicle, shall deposit Rs. 500/- per month for car and Rs. 400/- per month for jeep from their salary for use of the vehicle under which they have also entitled for personal use of Govt. vehicle upto 200 kms, and beyond that charges @ Rs. 3 per km is liable to be deposited in Govt. treasury. In the earlier office note dated 23.07.2021 there was a mention about the same Govt. orders etc. for which Court's Circular Letters were issued subsequently. The instant case of permission is required to be considered under the above mentioned Govt. orders. Moreover when as per the provisions of the G.O.s, the officer has stated that he shall pay the charges as per rule, his application appears to be considerable.

Moreover as the journey has already been performed, if the Hon'ble Court likes to consider his request, he may be granted ex-post facto permission for the same.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal & if His Lordship approves, Sri Mayank Kumar Jain, District & Sessions Judge, Gonda be granted ex-post facto permission to use official car no. UP-43-G-0414 for the journey mentioned above, subject to the condition to pay excess amount for the personal use of official car beyond 200 kms. monthly, if any, as per the provisions of relevant Rules and G.O.?
