May kindly see the online application received from Sri Vinay Kumar Jaiswal, Secretary, the then District Legal Services Authority, Basti presently posted as Additional Chief Judicial Magistrate (Railway), Moradabad regarding grant of permission for registration of the plot no. 2, Minjumala Khasra no. 336, measuring 1500 sq. ft., situated at village Dhava, Pargana Lucknow, Tehsil & Distt. Lucknow in the name of his wife Smt. Trisha Mishra.

In his application, Sri Vinay Kumar Jaiswal has stated that after grant of permission from the Hon'ble Court on Application ID no. 653, he had to purchase/get registered the sale deed of plot, situated at village-Dhava, Pargana-Lucknow, Tehsil & Distt Lucknow, measuring 1500 (25x60 feet) sq. ft. from Sri Pradeep Kumar Gupta, S/o Late Sri Ram Gopal Gupta R/o P.R.-1 Nehru Enclave, Gomti Nagar, Lucknow for Rs. 10,50,000/-, in his own name, but due to some personal reasons, now the registration of the plot is required to get in the name of his wife Smt. Trisha Mishra, Civil Judge (Sr. Div.), Moradabad, for which his wife has submitted due application separately. He has, therefore, requested to pass suitable orders for grant of permission to his wife for the same.

In this connection, it is submitted that the officer had already been granted permission to purchase the said property in his name, through online mode vide Court's order dated 06.08.2020 on Application ID no. 653. In the said application, an office note dated 05.08.2020 was submitted, in which following proposal was submitted:-

“Therefore, if approved, the file be laid before Hon’ble Mr. Justice Ali Zamin, Nominated Judge for disposal of the matters of Judicial Officers, of information/ permission of sale/ purchase of movable/ immovable property or gift etc., for His Lordship’s kind perusal and if His Lordship approves, Sri Vinay Kumar Jaiswal, Secretary, District Legal Services Authority, Basti may be granted permission to purchase plot no. 2, Minjumala Khasra no. 336, measuring 1500 sq. ft., situated at village Dhava, Pargana Lucknow, Tehsil & District Lucknow from Sri Pradeep Kumar Gupta S/o Sri Ram Gopal Gupta R/o P.R.-1, Nehru Enclave, Gomti Nagar, Lucknow for Rs. 10,50,000/-, as requested, subject to the condition that the relevant papers of the transaction alongwith copy of the sale deed be furnished by him immediately on completion of the transaction?”

Thus Hon'ble Mr. Justice Ali Zamin Nominated Judge for disposal of the matters of Judicial Officers for grant of permission for Basti Judgeship (officer's then posting) had been pleased to approve the same proposal on 06.08.2020. But as the officer has requested for registration of the aforementioned plot in the name of his wife now, it is desirable that the earlier Court's order dated 06.08.2020 may be got cancelled. Necessary steps for consideration of his wife's request on separate Application ID no. 2083 is to be taken which has also been processed separately on her application. At present, both the officers are posted at Moradabad Judgeship.

Under the facts & circumstances mentioned above, if approved, the matter may kindly be laid before Hon’ble Mr. Justice Pradeep Kumar Srivastava for cancellation of earlier granted permission to Sri Vinay Kumar Jaiswal, presently posted as Additional Chief Judicial Magistrate (Railway), Moradabad for purchase of plot no. 2, Minjumala Khasra no. 336, measuring 1500 sq. ft., situated at village Dhava, Pargana Lucknow, Tehsil & Distt. Lucknow, in his name due to the reasons, as mentioned above, and for consideration of application of his wife Smt. Trisha Mishra, Civil Judge (Sr. Div.), Moradabad, for the same now separately on another application ID no. 2083?
