

**Joint Registrar (Judicial) (Budget)**

May kindly see the online letter/application of Sri Dilip Kumar Sachan, Chief Judicial Magistrate, Etawah regarding grant of permission to purchase "32" bore (MK-II Ashani).

In his application, Sri Dilip Kumar Sachan has stated that as there is no security guard available to a judicial officer and keeping in the view of the nature of work of a judicial officer, it becomes necessary to purchase a fire arm for personal safety. Thus, he wants to purchase a "32" Pistol (MK-II Ashani) made by Gun and Shell Factory, Ghosipur. He has obtained Arm's license from the District Magistrate, Bijnor on 23.01.2021 license no.2840/IGS Bijnor valid upto 03.02.2024 (copy of the same can be seen as attachment) The estimated price of the proposed firearm is for Rs.92,400/- excluding taxes (copy of quotation can be seen as attachment). He will pay the price of the said firearm from his S.B.A/c No. 31379745691 S.B.I, Mandawar Road, Bijnor, in which he has a balance of Rs. 92,400/- as on 08.06.2021 (copy of passbook can be seen as attachment). He has therefore prayed for grant of permission to purchase the aforesaid firearm.

In this connection, it is submitted that according to this Hon'ble Court's C.L. no. 11/ IVh-16/ Admin (A) dated 12.04.2010, the officer is required to take permission of this Court to purchase firearm, for which he has requested. His request is considerable, as he has submitted sufficient details of the proposed transaction.

It is also submitted that earlier the matter has been submitted before Hon'ble Mr. Justice Om Prakash-VII, Nominated Judge for the purpose vide office note dated 26.08.2021, but the same has been returned due to change of nomination and it is now likely to be submitted before Hon'ble the Administrative Judge concerned as per the order of nomination passed by Hon'ble The Chief Justice vide order dated 28.10.2021.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Etawah, also nominated for "Disposal of the matters of Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the District Etawah, for His Lordship's kind perusal and if His Lordship approves, Sri Dilip Kumar Sachan, Chief Judicial Magistrate, Etawah be granted permission to purchase "32" bore (MK-II Ashani) made by Gun and Shell factory, Ghosipur for Rs. 92,400/- excluding taxes, as requested, subject to the condition that he will submit full details and papers of the transaction immediately after the purchase?
