May kindly see the online application of Smt. Machala Agarwal, the then Spl. Judge (SC/ST, Prevention of Atrocities Act), Budaun presently posted as Additional District Judge, Bulandshahar regarding information regarding sale of her old Maruti Vitara Brezza car bearing reg. no. UP14 CX4582, intimated through his application dated 14.07.2021.

Through her application, Smt. Machala Agarwal has stated that she has sold her old car having reg. no. UP14 CX4582 through G.S. Car Bazaar, Budaun to Sri Kunal Gupta S/o Sri Jitendra Prakash Gupta R/o flat no. 3, Pashupati Apartments near Akshar Vihar, 128 Civil Line, Bareilly, U.P. on 21.12.2020 for Rs. 3,50,000/-. The total price of the said car is stated to have been received by her in her S.B. A/c no. 20157407337, SBI Jogipura. (Copy of statement of A/c & consent letter of the officer can be seen as attachment). The officer has therefore, intimated about the sale of her old car for kind perusal of this Hon'ble Court.

In this connection, it is submitted that the officer has purchased the car in the year 2016. She has also informed about the said car to the Hon'ble Court in her property statement for the year 2017-19 & 2019-21 in Case ID 4346 & 4812. Thus, as she has sold the car through a regular and reputed dealer, there seems to be nothing objectionable as per the Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956, which is as follows:-

24 (2):- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Bulandshahar, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
