

**Joint Registrar (Judicial)(Budget)**

May kindly see the letter dated 22.07.2021 of Sri Ankit Verma, Civil Judge (Junior Division), Kannauj, requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 2170. In this connection, it is submitted that initially the documents, furnished by Sri. Ankit Verma, Civil Judge (Junior Division), Kannauj (uploaded online on 22.07.2021) were not duly attested, thus inadmissible for inclusion of his qualification in his service records.

Thereafter, an online objection, dated 05.08.2021, was raised by office of this Court and in compliance of same Sri. Ankit Verma, Civil Judge (Junior Division), Kannauj, has further submitted the attested copies of LL.M mark-sheets (both the years) and copy of Degree (uploaded online on 12.08.2021) for inclusion of his qualification in his service records.

In this connection, it is submitted that Sri. Ankit Verma, joined the U.P. Judicial Service on 06.07.2018, initially as Additional Civil Judge (Junior Division), Kannauj. Here, it is relevant to mention here that Sri. Ankit Verma pursued his LL.M. course from Distance Learning Education from Kurukshetra University after duly taking permission from the office of the High Court vide Court's letter no. 15652/IV-4561/Admin A-4 dated 01.11.2019. Besides, as evident from submitted attested copies of LL.M mark-sheets (both the years) and copy of Degree (uploaded online on 12.08.2021), Sri. Ankit Verma, completed two-years LL.M. degree course in the year 2019 and was subsequently awarded Degree from Kurukshetra University, Haryana on 31.12.2020, thus said qualification may be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri. Ankit Verma, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid requisition dated 22.07.2021 (attached online on 12.08.2021) of Sri. Ankit Verma, Civil Judge (Junior Division), Kannauj, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Vikas Kunvar Srivastav, Administrative Judge, Kannauj, for kind perusal and order to the effect that copy of mark-sheets (both the years) and degree of LL.M (attached online on 12.08.2021) as well as attested copy of form of U.P. Nyayik Sewa of Sri. Ankit Verma, Civil Judge (Junior Division), Kannauj, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
