HR 05AK0200 to the same dealer from where new car has been purchased.

Through his application, Sri Malkhan Singh has submitted information about purchase of a new car, purchased on 21.06.2021; by giving pointwise details as per Hon'ble Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Samta Motors Pvt. Ltd., 119/8 Mile stone G.T. Road NH-44, Karnal, Haryana for Rs. 13,73,869/including registration and insurance charges (copy of tax-invoice can be seen as attachment). The source of money, as stated by the officer is Rs. 1,00,000/- given as booking amount/ advance to the car dealer vide cheque no. 03804 dated 17.05.2021 from his PNB salary S.B. A/c and Rs. 9,50,000/- has been taken as loan amount from Central Bank of India, Main Market, Karnal; repayable in 84 EMIs of Rs. 14,455/- (copy of 'loan sanction letter' can be seen as attachment). By clubbing the loan amount from the amount of Rs. 3,40,000/- (transferred to Central Bank of India account from his salary account of Punjab National Bank), Rs. 12,73,869/- stated to be paid through cheque no. 54121 dated 22.06.2021to the car dealer. The officer has also added that he has sold his old car Hyundai Magna Grand I-10 to Samta Motors Pvt. Ltd. For Rs. 2,43,012/- and the amount was received through Cheque no. 871225 dated 30.06.2021 in his PNB S.B. A/c. (relating debit and credit entries can be seen as attachment). The dealer from whom the said cars has been purchased and sold by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the new car and also sold his old car from/to a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mrs. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Muzaffarnagar, for Her Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
