May kindly see the online application of Sri Gajendra Singh, Civil Judge (Senior Division), Jalaun at Orai who, joined service on 12.01.2017, drawing gross salary of Rs. 1,00,035/- & take home salary of Rs. 86,899/- regarding information about purchase of a new Maruti Dzire car, allotted reg. no. UP85 BW8777, intimated through application dated 28.07.2021.

Through his application, Sri Gajendra Singh has submitted information about purchase of a new car on 09.04.2021 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Uma Motors Pvt. Ltd., who is a regular & reputed dealer, for Rs. 7,83,500/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 5,00,000/- has been taken as loan from State Bank of India, repayable in 60 EMIs of Rs. 10,019/- (copy of loan arrangement letter can be seen as attachment), rest Rs. 2,83,500/- is stated to have been paid out of his own S.B. A/c no. 36492342561 i.e. (Rs. 11,000/- through cheque Rs. 2,00,000/- & Rs. 72,500/- through cheque) (copy of statement of A/c & receipts can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The matter was previously submitted to Hon'ble Mr. Justice Ajai Kumar Sivastava-I, Nominated Judge, through detailed office note dated 28.08.2021, placed above but the matter has been reverted back. Thereafter, as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Jalaun at Orai, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
