

**Registrar (Judicial) (Budget)**

May kindly see the online application of Sri Arvind Kumar Yadav-II, the then Additional District & Sessions Judge, Firozabad presently posted at Bareilly who joined service on 15.06.2006, drawing gross salary of Rs. 1,59,573/- & take home salary of Rs. 1,29,173/- regarding information about purchase of a new Hyundai Creta car, allotted reg. no. UP83BA9909, after sale of his old Ford Icon car, intimated through application dated 03.08.2021.

Through his application, Sri Arvind Kumar Yadav-II has submitted information about purchase of a new Hyundai Creta car on 17.10.2020 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Rajendra Auto Wheels Private Limited, Etawah for Rs. 11,34,000/- in total, source of money of which is the bank loan from State Bank of India, Firozabad of Rs. 5,00,000/- repayable in 84 EMIs of Rs. 9,148/- (Copy of loan paper can be seen as attachment- loan certificate), Rs. 6,30,000/- is stated to have been paid out of his own S.B. A/c no. 11082791313, SBI through three cheques on 14.10.2020 for Rs. 1,30,000/-, Rs. 4,00,000/- and Rs. 1,00,000/- (Copy of account statement can be seen as attachment- Bank statement about payment) as well as cash deposit of Rs. 4,000/-. Other papers i.e. Invoice of the car and registration certificate are also annexed as attachment. The officer has also informed about sale of his old Ford Icon car having registration no. UP-62-L-8703 to one Sri Wasim, S/o Sri Sarfuddin, Firozabad for Rs. 30,000/- as scrap, which is less amount of his one month's basic pay, hence un-objectionable (Copy of sale letter can be seen as attachment- sale certificate of UP-62-L-8703). The dealer from whom the said car has been purchased by the officer and the purchaser to whom the old car is sold are neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and sold his old car for less than one month's of his basic pay and has also submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly, also Nominated Judge for disposal of the matters of Judicial Officers, of information/permission of sale/purchase of movable/immovable property or gift etc., for the District Bareilly for His Lordship's kind perusal, information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
