May kindly see the online application of Sri Pran Vijay Singh, Additional District & Sessions Judge, Bareilly by which he has submitted supplementary details/ papers in connection with information about purchase of a new MG Hector Diesel 2.0 MT Smart car in compliance of Court's order.

In this connection, it is submitted that earlier the officer had informed about purchase of a MG Hector Diesel 2.0 MT Smart car on 24.02.2021 for Rs. 19,94,236/-, intimated through application dated 09.08.2021, which was submitted before Hon'ble Mr. Justice Ali Zamin, Nominated Judge, vide office note dated 27.09.2021, whereupon by perusal of copy of bank statement submitted by the officer as attachment, His Lordship has been pleased to order on 23.10.2021 that:-

"Kindly clarify as to how you have paid Rs. 34,260/- in cash for the payment of the aforementioned car when you have only debited Rs. 20,000/- in the month of February. Moreover, you should also clarify as to why you have paid Rs. 40,000/- on 13.08.2020 to Sri Saurabh Singh, Rs. 40,000/- on 30.09.2020, 40,000/- on 03.11.2020 & 40,000/- on 07.11.2020 to Sri Chandrajeet Singh, as both of them do not seem to be your family members".

The order was communicated online to the officer.

In compliance of Court's order dated 23.10.2021, Sri Pran Vijay Singh replied that Sri Chandrajeet Singh was his Court Moharrir & very often the officer used to withdraw cash from Sri Chandrajeet Singh through cheque for his personal needs. Moreover, Sri Saurabh Srivastava was a SBI employee, from whom on 13.08.2020 the officer has withdrawn Rs. 40,000/- for his personal needs as during court hours he is unable to visit bank to withdraw cash. As far as the payment of Rs. 34,260/- in cash is concerned, Rs. 21,000/- has been paid on 25.10.2020 as booking amount and Rs. 13,260/- has been paid on 24.02.2021 at the time of taking delivery of the car. The same amounts are stated to have been available with him as savings from earlier drawn amounts from the bank for his personal use.

Under the facts & details mentioned above, if approved, the matter may be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly, also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district, for His Lordship's kind perusal & further order in the matter of acceptance of information about purchase of new MG Hector Diesel 2.0 MT Smart car under Rule 24 (2) of U.P. Government Servant's Conduct Rules, 1956 ?
