May kindly see the online requisition dated 29.08.2021 of Sri Gaurav Deep Singh, the then Additional Civil Judge (Junior Division), Sadabad-Hathras & now posted as Civil Judge (Junior Division), Basti requesting for inclusion of LL.M. Degree in his service records vide Case Id No. 12852021. In compliance of same, Sri Gaurav Deep Singh furnished his LL.M. credentials comprising of attested copies of Mark-sheets of all the semesters and provisional certificate of Degree.

Thereafter, an online objection, dated 13.09.2021, was raised by the office of the Court asking Sri Gaurav Deep Singh to furnish the attested copy of Degree. In compliance of same, Sri Gaurav Deep Singh furnished attested copy of Degree vide dated 10.04.2022. Further, another objection, dated 18.04.2022, was raised by the office to clarify the ambiguity in the date of issuance of Mark-sheets. Sri Gaurav Deep Singh, vide dated 19.04.2022, submitted the reason behind the said query.

In this connection, it is submitted that Sri Gaurav Deep Singh, joined the U.P. Judicial Service on 18.11.2019 as Additional Civil Judge (Junior Division), Hathras. Besides, as evident from submitted copies of Mark-sheets (four semesters) and Degree of LL.M., Sri Gaurav Deep Singh completed two years LL.M. course, and was subsequently awarded Degree from Chaudhary Charan Singh University, Meerut on 30.09.2019 for the examination year 2019, prior to joining the Judicial Service, thus said qualification may be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Gaurav Deep Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 29.08.2021 of Sri Gaurav Deep Singh, the then Civil Judge (Junior Division), Sadabad-Hathras & now posted as Civil Judge (Junior Division), Basti may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Basti, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (four semesters) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Gaurav Deep Singh, the then Additional Civil Judge (Junior Division), Sadabad-Hathras & now posted as Civil Judge (Junior Division), Basti, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
