May kindly see the online application of Smt. Shabistan Aquil, Additional District & Sessions Judge, Lalitpur who joined service on 23.06.2006, drawing gross salary of Rs. 1,92,387/- & take home salary of Rs. 1,43,956/- regarding information about purchase of new KIA Sonet G1 2 5MT HTK Plus car, allotted reg. no. DL3CCU0802, intimated through application dated 08.10.2021.

Through her application, Smt. Shabistan Aquil has submitted information about purchase of new car on 23.06.2021 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from KIA India Pvt. Ltd. who is an authorised dealer, for Rs. 8,65,000/- (Cost Price Insurance Road Tax) which comes to Rs. 9,74,639/- out of which cost price of the car is 8,65,000/-, Rs. 34,714/- as insurance and remaining amount is paid as road tax (copy of 'invoice' can be seen as attachment), source of which is that Rs. 3,50,000/- has been taken as loan from HDFC Bank repayable in 24 EMIs of Rs. 15,838/- (copy of 'loan arrangement letter' can be seen as attachment) & Rs. 6,24,639/- is stated to have been paid out of her own S.B. A/c i.e. Rs. 25000/- on 02.02.2021(Through Cheque), Rs. 5,84,539/- on 23.06.2021 (Through NEFT/RTGS), Rs. 15100/- on 28.06.2021 (Through Cheque)(Copy of 'statement of A/c' can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Lalitpur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the district Lalitpur, for His Lordship's kind perusal and information under Rule 24 (2) of the U.P. Government Servant's Conduct Rules, 1956?
