The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The matter was previously submitted to Hon'ble Mr. Justice Pradeep Kumar Srivastava, Nominated Judge, through detailed office note dated 15.09.2021, placed above, and after retirement of Hon'ble Nominated Judge, the matter has been reverted back. Government Servants' Conduct Rules 1956" for the district Kushinagar at Padrauna, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
