

Joint Registrar (Judicial) (Budget)

May Kindly see the online application of Sushri Nikita Sengar, Additional Civil Judge (Junior Division), Hardoi by which she has requested for grant of permission to appear for the examination of Andhra Pradesh Judiciary 2021 (Notification no. 9/2020-RC) and another examination of Andhra Pradesh Judiciary (Notification no. 2/2021-RC).

In her application, Sushri Nikita Sengar has stated that she wants to appear for the Andhra Pradesh Judiciary 2021 (Notification no. 9/2020-RC) examination, scheduled to be held on 26.09.2021 and another examination of Andhra Pradesh Judiciary (Notification no. 2/2021-RC), scheduled to be held on 03.10.2021. Thereafter the officer was asked to intimate about her appearance in the aforesaid examination, scheduled on 26.09.2021 and also be asked to upload complete details of both the examinations. In reply of the same the officer has stated that she has appeared for the examination dated 26.09.2021 in anticipation of permission of Hon'ble High Court and the second examination dated 03.10.2021 is yet to be appeared for. She has also apologized for the delay in putting up application for permission and stated that the delay occurred due to personal health reasons, since she was not sure about appearing in the exam due to health issue. It is also pertinent to mention here that as asked by Joint Registrar (Judicial) (Budget), the officer was asked to intimate recent status of exam scheduled on date 03.10.2021 that whether she appeared or not. In reply the officer has stated that she has appeared for the exam scheduled on 03.10.2021. She has also enclosed the copy of notifications and Hall tickets of the aforesaid examinations. She has, therefore, humbly requested for grant of permission to appear in the aforesaid examinations.

In this connection, it is submitted that the officer has joined Uttar Pradesh Nyayik Sewa on 16.11.2019. It is also pertinent to mention here that the officer has already appeared for the examinations of Andhra Pradesh Judiciary 2021 (Notification no. 9/2020-RC) examination and examination of Andhra Pradesh Judiciary (Notification no. 2/2021-RC), scheduled to be held on 03.10.2021. Now it's upto the discretion of the Hon'ble High Court to grant her ex-post facto permission for her appearance in both the examination of Andhra Pradesh Judiciary, to regularize the matter or to pass any other order which His Lordship deems fit and proper.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Hardoi for His Lordship's kind perusal and orders to the effect that ex-post facto permission be granted to Sushri Nikita Sengar, Additional Civil Judge (Junior Division), Hardoi for her appearance in the preliminary examinations of Andhra Pradesh Judiciary 2021 (Notification no. 9/2020-RC) and Andhra Pradesh Judiciary (Notification no. 2/2021-RC), as requested, subject to the conditions mentioned above?

Or

To pass any other order which His Lordship deems fit and proper.
