May kindly see the letter dated 28.09.2021 & 30.10.2021 ( received online) of Sushri Preeti Bhasker, Registrar, Land Acquisition Rehabilitation and Resettlement Authority, Jhansi, requesting for inclusion of her Ph.D. Degree in her service records and add prefixing of 'Doctor' with her name vide Case Id. No. 13582021 (Old Case Id 2439) .

In this connection, it is submitted that Sushri Preeti Bhasker, aforesaid, joined U.P. Judicial Services on 14.12.2019 as Civil Judge (Junior Division), Jhansi. Besides, as evident from her submitted attested copy of her degree of Ph.D., Sushri Preeti Bhasker was awarded the degree of Doctor of Philosophy (Ph.D.) in the department of Human Rights, School for Legal Studies for the topic "Physical Violence Against Women and Compensatory Jurisprudence with Special Reference to Acid Attack Victims Working in Sheroes Cafe of Uttar Pradesh" in the year 2020 from Babasahab Bhimrao Ambedkar University, Lucknow and Degree was issued on 26.08.2021. Nevertheless, relevant details about course completion is not mentioned in her application form of U.P. Nyayik Sewa/UPHJS, thus said qualification is required to be included and prefixing of 'Doctor' before her name in her service-records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P. ,thus said qualification of Ph.D. Degree and prefixing of 'Doctor' before her name may be included in service-records of Sushri Preeti Bhasker, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 28.09.2021& 30.10.2021(received online) of Sushri Preeti Bhasker, Registrar, Land Acquisition Rehabilitation and Resettlement Authority, Jhansi may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Jhansi, for kind perusal and if Her Lordship approves for order to the effect that copy of aforesaid letter dated 28.09.2021 & 30.10.2021(received online) along with attested copy of Ph.D. Degree as well as attested copy of form of U.P. Nyayik Sewa of Sushri Preeti Bhasker, Registrar, Land Acquisition Rehabilitation and Resettlement Authority, Jhansi may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
