A/c (copy of statement of A/c can be seen as attachment).The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court. It is pertinent to mention here that the officer has also stated that initially they were swiching to this portal from ordinary manner which caused delay. Afterwards Covid-19 affected all the work. Kindly place the information before Hon'ble Court with aplogies and request to condone the delay.
