May kindly see the online application of Sushri Nikita Sengar, Additional Civil Judge (Junior Division), Hardoi regarding grant of permission to visit Male, Maldives after her wedding from 25.12.2021 to 31.12.2021.

In her application, Sushri Nikita Sengar has stated that she wants to visit Male, Maldives for honeymoon with her husband from 25.12.2021 to 31.12.2021. She has also stated that expenditure in her honeymoon trip would be approximately around Rs. 90,000/- including Flight Tickets of approximately Rs. 35000, Accommodation and Fooding of approximately Rs. 40000, Travel and Other Expenses of approximately Rs. 15000. She has further stated that according to Circular Letter dated 25.05.2017 of the Hon'ble High Court of Judicature at Allahabad the application to seek permission to visit abroad should be forwarded two months prior to the proposed visit and also, as per the circular, abroad visit for pleasure trips should be applied for the non working days of Hon'ble Court. There is no requirement for pre- arrival visa to visit Maldives, She has also enclosed the copy of passbook as attachment and declared as follows:-

1. That her visit to abroad in no way is likely to create any dilemma before the Govt. of India or before Govt. of U.P.
2. That she has not visited any foreign country before.
3. That such type of request for abroad visit was not refused to her earlier
4. That in no circumstance she would overstay abroad without leave or extended leave and she would resume her duties respectively by 1st January 2022 hence the visa would be received on arrival at the destination.

It is also pertinent to mention here that as asked by Joint Registrar (Judicial) (Budget), the officer was aksed to upload the copy of her passport and in reply the officer has also uploaded the copy of passport which can be seen as attachment. She has, therefore requested for grant of permission to visit Male, Maldives after her wedding for honeymoon trip from 25.12.2021 to 31.12.2021.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, no vigilance/ departmental enquiry is pending against Sushri Nikita Sengar. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit Male, Maldives alongwith her husband after their marriage, this trip appears to be a pleasure trip from 25.12.2021 to 31.12.2021 and all the days of her trip falls during winter holidays, her request appears to be considerable. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Vide subsequent order dated 19.10.2020, Hon'ble the Chief Justice has been pleased to nominate Hon'ble Mr. Justice Pritinker Diwaker, to consider request of permission of the Judicial Officers to visit abroad in his Lordship's place.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Hardoi for kind perusal and if His Lordship approves, Sushri

Nikita Sengar, Additional Civil Judge (Junior Division), Hardoi may be granted permission to visit Male, Maldives after her wedding from 25.12.2021 to 31.12.2021, as requested, subject to approval by Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 19.10.2020 of Hon'ble the Chief Justice, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
