

## **Joint Registrar (J)(Budget)**

May kindly see the letter dated 04.10.2021 (uploaded online on 01.10.2021) of Sushri Kavya Singh, Civil Judge (Junior Division), Gonda, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 2451. In compliance of same, Sushri Kavya Singh furnished her LL.M. credentials comprising mark-sheet (only 3rd & 4th semesters) and copy of degree (uploaded online on 01.10.2021) for inclusion of her qualification in her service records.

Thereafter, an online objection regarding partial updation of LL.M. credentials, dated 06.10.2021, was raised by office of this Court and in compliance of same Sushri Kavya Singh, Civil Judge (Junior Division), Gonda, has further submitted the attested copies of LL.M mark-sheets and copy of Degree (uploaded online on 14.10.2021), for inclusion of her qualification in her service records.

In this connection, it is submitted that Sushri Kavya Singh, joined the U.P. Judicial Service on 14.06.2018, as Judicial Magistrate, Gonda. Besides, as evident from submitted attested copies of mark-sheet (four semesters) and degree of LL.M. (uploaded online on 01.10.2021 & 14.10.2021), Sushri Kavya Singh completed two years LL.M. course, for the academic session 2014-16, and was subsequently awarded Degree from University of Lucknow, Lucknow on 12.01.2017 for the examination year 2016, thus said qualification may be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sushri Kavya Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 04.10.2021 (uploaded online on 04.10.2021) of Sushri Kavya Singh, Civil Judge (Junior Division), Gonda, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda, for kind perusal and order to the effect that a copy of her application (uploaded online on 04.10.2021) along with copy of mark-sheet (four semesters) and degree of LL.M (uploaded online on 01.10.2021 & 14.10.2021) as well as attested copy of form of U.P. Nyayik Sewa of Sushri Kavya Singh, Civil Judge (Junior Division), Gonda, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
