

Joint Registrar (Judicial)(Budget)

May kindly see the letter dated 05.10.2021 (uploaded online on 05.10.2021) of Sri Ravindra Kumar-IV, Presiding Officer, Motor Accident Claim Tribunal, Hardoi requesting for inclusion of his LL.M. qualification in his service records vide Case Id 13782021 (Old Case Id 2459). In compliance of same, Sri Ravindra Kumar-IV furnished all his LL.M. credentials comprising LL.M. mark-sheets of both the years and copy of Degree for inclusion of his qualifications in his service records.

In this connection, it is submitted that Sri Ravindra Kumar-IV joined the U.P. Judicial Service on 19.08.2013, as Additional District & Session Judge, Kushi Nagar at Padrauna. Besides, as clear from submitted attested copies of mark-sheet (two years) and degree of LL.M. (uploaded online on 05.10.2021), Sri Ravindra Kumar-IV completed two years LL.M. course, for the academic session 2018-2020, and was subsequently awarded degree from Kurukshetra University, Kurukshetra on 30.09.2021 for the examination year 2020, thus said qualification may be included in his service-records.

It is pertinent to mention here that Admin A-4 section, through offline note, approved by the then Hon'ble Chief Justice dated 02.10.2019 and vide Hon'ble Court's letter no. 15564/IV-4052/Admin A-4 dated 31.10.2019 granted permission to concerned Judicial Officer to appear before LL.M. examination conducted by Kurukshetra University.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Ravindra Kumar-IV, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 05.10.2021 of Sri Ravindra Kumar-IV, Presiding Officer, Motor Accident Claim Tribunal, Hardoi, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Hardoi, for kind perusal and order to the effect that a copy of his application along with copy of mark-sheet (two years) and degree of LL.M. (uploaded online on 05.10.2021) as well as attested copy of form of U.P. Nyayik Sewa of Sri Ravindra Kumar-IV, Presiding Officer, Motor Accident Claim Tribunal, Hardoi, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
