<u> Joint Registrar (J) Budget</u>

May kindly see the online application of Sri Vikas Nagar, Additional District & Sessions Judge, Jhansi regarding grant of permission to purchase 0.32 Bore Pistol.

In his application, Sri Vikas Nagar has stated that he wishes to purchase firearm. Earlier, he was granted permission by the Hon'ble Court in Case Id no. 409 (approved by this Hon'ble Court on 10.02.2020). But due to Covid pandemic, he could not purchase the firearm. Moreover, the same Pistol G.S.F. Indian Ordinance Factory, Kolkata is available @ 95,000/- from a local arms dealer 'Jhansi Gun House'. The quotation of the same can be seen as attachment. It is also pertinent to mention here that in his earlier request, the price of the said pistol was quoted 92,160/- for which permission has already been granted to him but the said purchase is to be done from Kolkata and it would be difficult for him to procure it from there. The same product is available here at his place of posting @ 95,000/-, and hence it will not only be less time consuming and comfortable but also economical for him as going to Kolkata to purchase the same will certainly incur expenses and total value would be more than the value he has to pay here. He will pay the price of the proposed firearm from his S.B. A/c No. 11122509597 SBI, Lucknow, in which he has a balance of Rs. 4,22,370/- as on 01.10.2021 (copy of statement of A/c can be seen as attachment). He has, therefore, prayed for grant of permission to purchase the aforesaid firearm from the local arms dealer namely 'Jhansi Gun House'.

In this connection, it is submitted that according to this Court's C.L. no. 11/ IVh-16/ Admin (A) dated 12.04.2010, the officer is required to take permission of this Court to purchase firearm, for which he has requested. Permission has already granted to him for the esaid 0.32 bore Pistol from Ordinance Factpry borad, Kasipur, Kolkata for Rs. 92,100/- on E-service Id no. 409, but as he has now intended to purchase the same firearm from local arms dealer due to his convenience though a little bit exoensive i.e. Rs. 95,000/- he has requested for fresh sanction of The Hon'ble Court. His request is considerable, as he has submitted sufficient details of the proposed transaction.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Jhansi, also nominated for "Disposal of the matters of the Judicial officers wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for His Lordship's kind perusal and, if His Lordship approves, Sri Vikas Nagar, Additional District & Sessions Judge, Jhansi be now be granted permission to purchase 0.32 Bore Pistol from local arms dealer namely 'Jhansi Gun House' for Rs. 95,000/-, as requested, subject to the conditions that relevant papers of purchase transaction be submitted by him immediately after its completion?
