May kindly see the online application of Sri Divyakant Singh Rathore, Judicial Magistrate, Gautam Budh Nagar who has joined his service on 01.08.2018, drawing gross salary of Rs. 91,113/- & take home salary of Rs. 77,908/- regarding information about purchase of a new Maruti Suzuki Dzire Vxi Petrol car jointly along with his wife, allotted reg. no. UP95S9920, intimated through application dated 10.10.2021.

Through his application, Sri Divyakant Singh Rathore has submitted information about purchase of a new car on 02.09.2021 by giving point wise details as per Court's C.L. no. 25/Admin(A) dated 13.07.1998, according to which the car has been purchased by him from Suri Automobiles, 362/1, Nehru Marg, Civil Lines, Jhansi, Branch Office at Gandhi Nagar, Mahoba who is an authorized dealer, for Rs. 7,80,294/- in total (copy of invoice can be seen as attachment), source of money of which is that Rs. 4,00,000/- has been taken as loan from State Bank of India, repayable in 60 monthly installments of Rs. 8,015/- (copy of 'loan arrangement letter' can be seen as attachment) & rest Rs. 3,83,787/- is stated to have been paid out of his own S.B. A/c. The actual amount paid was Rs. 7,83,787/- for the purchase of the aforementioned car but due to less registration charges imposed than anticipated, the remaining amount Rs. 3,493/- was paid by the dealer through cheque in favour of the officer's A/c (copy of statement of A/c can be seen as attachment). It is pertinent to mention here that Rs. 1,50,000/- is stated to have been transferred to his A/c by his wife Smt. Arpita Singh (copy of statement of A/c of his wife can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautam Budh Nagar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Gautam Budh Nagar for His Lordship's kind perusal and information under Rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
