May Kindly see the online application of Sushri Jyotsna Mani Yaduvanshi, Judicial Magistrate, Agra by which she has requested for grant of permission to appear in preliminary and Mains Examination of Uttar Pradesh Combined State/ Upper Subordinate Services Examination, 2021 PCS/ACF-RFO Examination-2021, conducted by Uttar Pradesh Public Service Commission.

In her letter, Sushri Jyotsna Mani Yaduvanshi has stated that she wants to appear in preliminary examination of Combined State/ Upper Subordinate Services PCS/ ACF-RFO (Preliminary) Examination, 2021, scheduled to be held on 24th October 2021. Thereafter, the officer was asked to intimate about his appearance in the aforesaid preliminary examination and also be asked to attach notification of the examination. In reply, the officer has apologized for not submitting the notification and stated that it is by an error of memory that the delay is caused in seeking permission from the Hon'ble High Court and added that she has appeared in the UPPCS Combined Upper State Services Exam Preliminary exam and cleared the same. The Mains Examination is scheduled to begin from 28.01.2022 and would be concluded on 31.01.2022. She has, therefore, requested for grant of permission to appear in the above examination.

In this connection, it is submitted that the officer has joined the Uttar Pradesh Nyayik Sewa on 01.10.2019. It is pertinent to mention here that as the officer has cleared the preliminary examination and now wants to appear in the Mains examination of the same; now it is on the discretion of Hon'ble High Court either to grant her ex post facto permission for her appearance in the preliminary examination and permission to appear in the Mains examination of Uttar Pradesh Combined State / Upper Subordinate Services (PCS) Examination, 2021, which is scheduled to be held from 28.01.2022 as stated by the officer or to pass any other order which His Lordship deems fit and proper. Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

- 1. Government work should not suffer in any way.
- 2. No preferential treatment will be given in the matter of leave, postings and transfer.
- 3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglect her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Agra for His Lordship's kind perusal and orders to the effect that ex post facto permission be accorded to Sushri Jyotsna Mani Yaduvanshi, Judicial Magistrate, Agra for her appearance in the preliminary examination and permission to appear in the Mains examination of Uttar Pradesh Combined State/ Upper Subordinate Services PCS/ACF-RFO Examination, 2021, conducted by Uttar Pradesh Public Service Commission, as requested, subject to the conditions mentioned above?
