May Kindly see the online application of Sri Chandra Prakash Tiwari, Additional Civil Judge (Junior Division), Kasia- Kushinagar by which he has requested for grant of permission to appear in preliminary and Mains Examination of Uttar Pradesh Combined State / Upper Subordinate Services (PCS) Examination, 2021 (PCS), conducted by Uttar Pradesh Public Service Commission.

In his letter, Sri Chandra Prakash Tiwari has stated that he wants to appear in preliminary examination of Combined State / Upper Subordinate Services (PCS) (Preliminary) Examination, 2021, scheduled to be held on 24th October 2021. Thereafter, as asked by Joint Registrar (Judicial) (Budget), the officer was asked to intimate about his appearance in the aforesaid preliminary examination. In reply, the officer has stated that he has appeared for the said exam on date 24.10.2021 and he has also qualified for the mains examination. Again, the officer was asked to intimate about the date of mains examination of the aforesaid examination. In reply, the officer has stated that the Uttar Pradesh Public Service Commission Mains exam 2021 is scheduled to begin from 28.01.2022 as per exam calender of Commission and as per last year trend it should be held on 28.01.2022, 29.01.2022 , 30.01.2022 and 01.02.2022. He has, therefore, requested to the Hon'ble High Court for grant of permission to appear in the said examinations.

In this connection, it is submitted that the officer has joined the Uttar Pradesh Nyayik Sewa on 15.11.2019. It is also pertinent to mention here that the officer has requested for issuance of 'No Objection Certificate' for appearing in the Mains examination but it is to submit here that 'No Objection Certificate' is issued at the level of interview only, thus only permission is supposed to be granted at this stage. Now, it is desirable that he may be accorded ex post facto permission for his appearance in the preliminary examination of the same and permission to appear in the Mains examination of Uttar Pradesh Combined State / Upper Subordinate Services (PCS) Examination, 2021, which is scheduled to be held from 28.01.2022 as stated by the officer as he has successfully passed the preliminary examination, if the Hon'ble High Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Kushinagar at Padrauna for His Lordship's kind perusal and orders to the effect that ex post facto permission be accorded to Sri Chandra Prakash Tiwari, Additional Civil Judge (Junior Division), Kasia- Kushinagar for his appearance in the preliminary examination and permission to appear in the Mains examination of Uttar Pradesh Combined State / Upper Subordinate Services (PCS) Examination, 2021, conducted by Uttar Pradesh Public Service Commission, as requested, subject to the conditions mentioned above?
