

**Joint Registrar (Judicial)(Budget)**

May kindly see the letter dated 28.10.2021 (uploaded online on 28.10.2021) of Sushri Shweta Soni, Civil Judge (Junior Division), Maharajganj, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 2507. In compliance of same, Sushri Shweta Soni furnished all her LL.M. credentials comprising mark-sheet (all the four) and copy of degree (uploaded online on 08.11.2021) for inclusion of her qualification in her service records.

Thereafter, an online objection, dated 08.11.2021, was raised by office of this Court and in compliance of same Sushri Shweta Soni, Civil Judge (Junior Division), Maharajganj, has further submitted all the attested copies of LL.M mark-sheets and copy of Degree (uploaded online on 15.11.2021), forwarded by District Judge, Maharajganj on 17.11.2021, for inclusion of her qualification in her service records.

In this connection, it is submitted that Sushri Shweta Soni, joined the U.P. Judicial Service on 16.12.2019, as Civil Judge (Junior Division), Maharajganj. Besides, as evident from submitted attested copies of mark-sheet (four semesters) and degree of LL.M. (uploaded online on 15.11.2021), Sushri Shweta Soni completed two years LL.M. course, for the academic session 2016-18, and was subsequently awarded Degree from University of Delhi, Delhi on 04.11.2019 for the examination year 2018, thus said qualification may be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sushri Shweta Soni, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 28.10.2021 (uploaded online on 28.10.2021) of Sushri Shweta Soni, Civil Judge (Junior Division), Maharajganj, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Maharajganj, for kind perusal and order to the effect that a copy of her application (uploaded online on 28.10.2021) along with copy of mark-sheet (four semesters) and degree of LL.M (uploaded online on 15.11.2021) as well as attested copy of form of U.P. Nyayik Sewa of Sushri Shweta Soni, Civil Judge (Junior Division), Maharajganj, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
