

## **Ld. Registrar (J)(Budget)**

May kindly see the letter dated 28.10.2021 of Sushri Annu, the then Additional Civil Judge (Junior Division), Kasganj, presently posted as Additional Civil Judge(Junior Division), Nagina-Bijnor (uploaded online on 28.10.2021), requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 14252021 (Old Case Id No. 2509). In compliance of same, Sushri Annu furnished her LL.M. credentials comprising LL.M mark-sheets of all the semesters and copy of Degree for inclusion of her qualifications in her service records.

Thereafter, an online objection was raised by the office of the Court regarding some clarification in the date of issuance of mark-sheet and in compliance of same Sushri Annu submitted her reply clarifying all the issues made by the office.

In this connection, it is submitted that Sushri Annu, joined the U.P. Judicial Service on 16.11.2019, as Additional Civil Judge (Junior Division), Kasganj. Besides, as clear from submitted attested copies of mark-sheet (four semesters) and degree of LL.M. (uploaded online on 28.10.2021), Sushri Annu completed two years LL.M. course, for the academic session 2017-2019, and was subsequently awarded Degree from Chaudhary Charan Singh University, Meerut on 30.09.2019 for the examination year 2019, thus said qualification may be included in her service-records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sushri Annu, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 28.10.2021 of Sushri Annu, the then Additional Civil Judge (Junior Division), Kasganj, presently posted as Additional Civil Judge(Junior Division), Nagina-Bijnor, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Bijnor, for His Lordship's kind perusal and order to the effect that a copy of her application (uploaded online on 28.10.2021) along with copy of mark-sheet (four semester) and degree of LL.M. (uploaded online on 28.10.2021) as well as attested copy of form of U.P. Nyayik Sewa of Sushri Annu, the then Additional Civil Judge (Junior Division), Kasganj, presently posted as Additional Civil Judge(Junior Division), Nagina-Bijnor, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
