May kindly see the online application received from Sri Mohammad Firoz, Civil Judge (Senior Division), Aligarh by which he has informed about acceptance of flat No.504, Tower Maple at sector 6, Gomti Nagar Extension Lucknow by his wife by way of its purchase by her father, from the share, she got from the family partition of her father's side.

Sri Mohammad Firoz, in his application, has stated that the father of his wife Sri Mohd. Javed Siddiqui purchased Flat No.504 TOWER MAPLE at sector 6, Gomti Nagar Extension Lucknow on 08.10.2020 in the name of his daughter Smt. Fiza Siddiqui (Officer's wife), from the share, she got from the family partition of her father's side. The sale consideration of Rs. 71,41,724/-is paid through cheque/NEFT transactions from the account of her father as per the share she got from the family partition (copy of passbook of her father can be seen as attachment. The officer has submitted copy of 'Sale Deed' & 'Gift Deed' in this regard as attachment. He has, therefore, submitted the information about the purchase of flat for kind perusal of the Hon'ble Court.

In this connection, it is submitted that the flat has been purchased by the father-in-law of the officer for his daughter (officer's wife) as her share in his father's property. It appears to be amounts as a 'Gift'.

It is further submitted that the Rule relating to gift (Rule 11 of the U.P. Government Servant's Conduct Rules, 1956) is as under:-

- 11.Gifts:- A government servant shall not without previous approval of Government :-
- (a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or
- (b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relation.

It is further submitted that as the flat has been purchased by the father-in-law of the officer to his daughter (officer's wife), being father & daughter in relation, the transaction appears to be non-objectionable as per above-mentioned rule.

May, therefore, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Aligarh, for His Lordship's kind perusal and information under Rule (11) of U.P. Government Servant's Conduct Rules, 1956?
