May kindly see the online requisition dated 24.11.2021 of Sushri Nimisha Gupta, the then Civil Judge( Junior Division), Auraiya, and Presently posted as, Civil Judge( Junior Division), Jewar, Gautambuddha Nagar, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 14852021. In view of the above, Sushri Nimisha Gupta, has furnished her duly attested scanned copies of LL.M. Mark-sheet (consolidated first and second semesters as well as separate) and of the Degree Qualification, as supporting documents for the same.

In connection with the above, it is submitted that Sushri Nimisha Gupta , joined the U.P. Judicial Service on 15.11.2019, initially as Additional Civil Judge(Junior Division), Auraiya and presently posted as Civil Judge(Junior Division), Jewar, Gautambuddha Nagar. Further, it is relevant to mention here that Sushri Nimisha Gupta pursued her LL.M. one year degree course from Vivekanandanada Institute of Professional Studies affiliated to Guru Govind Singh Indraprastha University, Delhi, in the year 2018-2019, prior to joining U.P. Judicial service.

In addition to the above, as evident from submitted attested copy of LL.M mark-sheet (consolidated first and second semesters as well as separately) and the copy of Degree Qualification, Sushri Nimisha Gupta, completed her one-year LL.M. degree course in the year 2019 and was subsequently awarded the LL.M. Degree from Guru Govind Singh Indraprastha University, Delhi on 03.12.2019, thus, the said qualification may be included in her service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sushri Nimisha Gupta, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 24.11.2021 of Sushri Nimisha Gupta, Civil Judge(Junior Division), Jewar, Gautambuddha Nagar, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar, for his Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheet (consolidated first & second semesters as well as separate) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Nimisha Gupta, Civil Judge( Junior Division), Gautambuddha Nagar,, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
