

## **Registrar(J)(Budget)**

May kindly see the online application received from Sushri Sakshi Singh, Judicial Magistrate, Ayoydhya (Faizabad) by which she has informed about acceptance of car as gift given to her, by her father.

Sushri Sakshi Singh, in her application, has stated that she owned a Maruti Zen car no. UP12L1794 prior to joining the service. The registration of the said car was due to expire in November 2020 owing to this, the officer was gifted a Maruti Swift Dzire VXI car having reg. no. UP19A9507 by her father (Sri Ved Pal Singh) out of natural love and affection on 29.09.2020, The said car was sanctioned to her father on 06.06.2014 under scheme VI (Rev). The said car was purchased in the name of LIC of India. (The purchase receipt can be seen as attachment). In the year 2019, her father became eligible to get a new car sanctioned to him upon exit of his old car. (The exit letter can be seen as attachment). Upon payment of the outstanding amount, (receipt can be seen as attachment) the ownership of the car changed from LIC of India to the name of her father i.e. Mr. Ved Pal Singh. Thereafter her father gifted the said car to her. She has submitted copy of both old & new 'Registration Certificates' of the car alongwith consent letter of her father in this regard as attachment. She has therefore, submitted the information about acceptance of gift as car for kind perusal of the Hon'ble Court.

In this connection, the relevant extract of rule relating to gift (Rule 11 of the U.P. Government Servant's Conduct Rules, 1956) is as under :-

*11.Gifts:- A government servant shall not without previous approval of Government :-*

*(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or*

*(b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relation.*

It is further submitted that as car has been gifted by her father to the officer out of natural love and affection, who are close blood relatives being father and daughter, there appears to be nothing objectionable as per above mentioned rule.

May, therefore, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Faizabad, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Faizabad, for His Lordship's kind perusal and information under Rule (11) of U.P. Government Servant's Conduct Rules, 1956?
