May kindly see the online application of Sri Rajesh Kumar Mishra, the then ADJ (FTC), Mainpuri presently posted as Additional District Judge, Gautambuddha Nagar who, joined service on 22.04.2009, drawing gross salary of Rs. 1,76,692/- & take home salary of Rs. 1,26,292/- regarding information about purchase of a new Hyundai Creta car, allotted reg. no. UP31 BS7188, intimated through application dtd. 16.12.2021.

Through his application, Sri Rajesh Kumar Mishra has submitted information about purchase of a new car on 08.10.2021 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from AKC Hyundai, AKC Auto (P) Ltd. near Crossing Bahraich road, Lakhimpur Kheri, U.P. who is an authorised dealer, for Rs. 12,62,939/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 10,50,000/- is stated to have been taken as loan from SBI, Lakhimpuri Kheri, repayable in 60 EMIs of Rs. 21,291/- (copy of loan arrangement letter can be seen as attachment)& rest Rs. 2,12,939/- is stated to have been paid to the dealer (i.e. Rs. 20,000/- on 28-09-2021 to the dealer as booking amount through his wife's account and subsequently he has paid Rs. 1,65,000/- to the dealer through his wife's account. These entries were in the bank statement of his wife's account. He has paid insurance amount Rs. 27939/- in cash and his wife has withdrawn cash Rs. 30,000/- on 6th August and 7th August 2021. These entries were also in the bank statement of his wife's account. So, the total amount Rs. 212939/- (20000 165000 27939= 212939) was paid through his wife's account). (copy of statement of A/c & receipt can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Gautambuddha Nagar nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Gautambuddha Nagar, for His Lordship's kind perusal and information under Rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
