May Kindly see the online application of Sri Pradeep Yadav, Additional Civil Judge (Junior Division), Pratapgarh by which he has requested for grant of permission to appear in the Mains Examination of Haryana Civil Service(Judicial Branch) Examination 2020-2021, conducted by Haryana Public Service Commission.

In his letter, Sri Pradeep Yadav has stated that on 13.01.2021 the Advertisement for the application of Civil Judge (Junior Division) was issued by the Haryana Public Service Commission vide Advertisement no. 1/2021 and the preliminary examination was conducted on 13.11.2021 and now result of the preliminary examination was declared on 07.12.2021 in which he has qualified for the Mains examination of the same. He has also stated that he has applied for permission to appear in the preliminary examination on 15.01.2021 which was approved by the Hon'ble High Court on 17.03.2021. The Mains Examination of the same is likely to take place very soon. The officre has also enclosed preliminary result, advertisement and other relating papers, which can be seen as attachment. He has, therefore, requested the Hon'ble High Court to grant him permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined the Uttar Pradesh Nyayik Sewa on 19.12.2019. It is also pertinent to mention here that the officer has requested for issuance of 'No Objection Certificate' for appearing in the Mains examination but it is to submit here that 'No Objection Certificate' is issued at the level of interview only, thus only permission is supposed to be granted at this stage. Earlier, Hon'ble the Administrative Judge, Pratapgarh, has been pleased to accorded permission (digitally signed on 19.07.2021) to apply and to appear in the preliminary exam of Haryana Civil Service (Judicial Branch) Examination-2020-2021. Now, it is desirable that he may be accorded permission to appear in the Mains examination of Haryana Civil Service (Judicial Branch) Examination 2020-2021, which is likely to be held very soon as stated by the officer as he has successfully passed the preliminary examination, if the Hon'ble High Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

- 1. Government work should not suffer in any way.
- 2. No preferential treatment will be given in the matter of leave, postings and transfer.
- 3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Rahul Chaturvedi, Administrative Judge, Pratapgarh for His Lordship's kind perusal and orders to the effect that permission be accorded to Sri Pradeep Yadav, Additional Civil Judge (Junior Division), Pratapgarh to appear in the Mains examination of Haryana Civil Service (Judicial Branch) Examination 2020-2021, conducted by Haryana Public Service Commission, as requested, subject to the conditions mentioned above?
