

## **Joint Registrar(J)(Budget)**

May kindly see letter dated 07.12.2021 along-with attested copies of mark-sheets (both semesters) and degree of LL.M qualification (uploaded online on 08.12.2021) of Sri Shakti Singh, Civil Judge (Junior Division), Varanasi, requesting for inclusion of LL.M qualification in his service-records.

Sri Shakti Singh, aforesaid, has requested for inclusion of LL.M. Qualification in his service records vide his online letter dated 07.12.2021 and has uploaded attested copies of mark-sheets (both semesters) and Degree of LL.M. Qualification (uploaded on 08.12.2021).

In this context, it is submitted that Sri Shakti Singh, aforesaid, joined U.P. Judicial Services on 16.12.2019 as Addl.Civil Judge (Junior Div.), Mirzapur. Besides, as apparent from submitted attested copies of mark-sheets (both semesters) and degree of LL.M. qualification (uploaded on 08.12.2021), Sri Shakti Singh, completed LL.M. course in year 2018 and was subsequently awarded Degree from Dr. Shakuntala Mishra National Rehabilitation University, Lucknow on 29.11.2021. Nevertheless, relevant details about course completion is not mentioned in his application form of U.P. Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Shakti Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 07.12.2021 of Sri Shakti Singh, Civil Judge (Junior Division), Varanasi may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Varanasi, for His Lordship's kind perusal and order to the effect that a copy of aforesaid letter dated 07.12.2021 along with attested copies of mark-sheets (both semesters) and degree of LL.M. (uploaded online on 08.12.2021), as well as attested copy of form of U.P.Nyayik Sewa of Sri Shakti Singh, Civil Judge (Junior Division), Varanasi, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
