May kindly see the online application of Smt. Kumud Upadhyay, Additional Civil Judge (Senior Division), Pratapgarh who has joined her service on 13.01.2017, drawing gross salary of Rs. 1,41,651/- & take home salary of Rs. 1,23,827/- regarding information about purchase of a new Hyundai I-20 Active VTVT SX (NM) car, allotted reg. no. UP65 CU2111 (copy of RC can be seen as attachment namely- Annexure no. 6), intimated through application dated 08.12.2021.

Through her application, Smt. Kumud Upadhyay has submitted information about purchase of a new Hyundai I-20 Active VTVT SX (NM) car on 23.06.2017 by giving point wise details as per Court's C.L. no. 25/Admin(A) dated 13.07.1998, according to which the car has been purchased by her from Natasha Automobile Pvt. Ltd., 4th Km Rampur Road, Bareilly, who is an authorized dealer, for Rs. 8,86,500/- (copy of invoice can be seen as attachment namely- Sale invoice), source of money of which is that Rs. 7,60,000/- has been taken as loan from State Bank of India, repayable in 92 monthly EMIs of Rs. 12,305/- (copy of loan arrangement letter can be seen as attachment namely- Annexure no. 5), Rs. 1,26,500/- (Rs. 20,000/- Rs. 1,05,000/- Rs. 1,500 in cash) is stated to have been paid by her cousin brother's (Ashutosh Kumar Malviya) A/c (copy of 'statement of A/c' and 'Consent letter' can be seen as attachments namely- Photocopy of passbook and Consent Letter). The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice J.J. Munir, Administrative Judge, Pratapgarh also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Pratapgarh for His Lordship's kind perusal and information under Rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
