A/c (copy of statement of A/c can be seen as attachment), source of which is that she has withdrawn Rs. 40,000/- on 09.06.2017, Rs. 20,000/- cash on 05.06.2017 and rest of the amount which she had paid to the dealer was her savings which she had withdrawn from her salary A/c from time to time. She has also apologized for not intimating about the purchase of car on prescribed time. She could not submit the said information on prescribed time because she was newly appointed civil judge and had no knowledge about the communication to Hon'ble Court regarding purchase of any new vehicle. She has affirmed that she will be vigilant and responsive in future.
