May kindly see the online application of Sri Padam Narain Mishra, District & Sessions Judge, Ambedkarnagar at Akbarpur, who joined service on 16.12.2008, drawing gross salary of Rs. 2,48,276/- & take home salary of Rs. 1,59,782/- regarding information about purchase of a new Volkswagen Vento Dem 1.5 Diesel, allotted reg. no. UP32 HV 9788, intimated through application dated 11.12.2021.

Through his application, Sri Padam Narain Mishra has submitted information about purchase of a new car on 29.03.2017 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Viraj Automobiles Pvt. Ltd., GT A-8, Sec-18, Noida, who is an authorized dealer of Volkswagen; for Rs. 8,51,000/- (car value of Rs. 7,33,000/- and registration and insurance charges of Rs. 1,18,000/-; copy of invoice can be seen as attachment). The source of money is stated to be loan amount of Rs. 4,50,000/- and the rest amount of down payment of Rs. 4,01,107/- is paid from his salary saving bank account. Thereafter through online objection, he was asked about his earlier purchase, about the credit entry of Rs. 4,00,000/- and about his loan repayment status. In reply, the officer has stated that no earlier purchase was done after joining of service and entry shown of Rs. 4,00,000/- is been given by her wife and the amount was received after maturity of F.D. no. 081913000437 on 14.02.2017(copy of his wife's statement can be seen as attachment) He has also stated that his wife is also earning member since 2000 and is working as astrologer since 2010 and prior to 2008 she was in job. He has further added that car loan amount has also been paid by him. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rajendra Kumar-IV, Administrative Judge, Ambedkar Nagar at Akbarpur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956 for the district Ambedkar Nagar at Akbarpur for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956 ?
