May kindly see the online application of Dr. Anil Kumar Singh-II, Additional District and Sessions Judge, Kaushambi who joined service on 17.04.2009, drawing gross salary of Rs. 1,92,502/- & take home salary of Rs. 1,55,023/- regarding information about purchase of a new Hyundai I-20 Asta car, allotted reg. no. UP23 Q 6444, in exchange of his old car, intimated through application dated 14.12.2021.

Through his application, Dr. Anil Kumar Singh-II has submitted information about purchase of a new Hyundai I-20 Asta car on 20.04.2015 by giving pointwise details as per Hon'ble Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Arjun Vasu Automobiles Pvt. Ltd., Moradabad for Rs. 8,02,536/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 1,95,000/- is stated to have been adjusted in exchange of his old car (copy of 'buying receipt' can be seen as attachment) Rs. 6,00,000/- has been taken as loan from S.B.I, Amroha, repayable in 72 monthly EMIs of Rs. 10,100.80/- (copy of 'loan arrangement letter' can be seen as attachment) & rest Rs. 7,536/- is stated to have been paid by clubbing the loan amount (Copy of the statement of A/c can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court. It is pertinent to mention here that the officer has sent the reason as to why he has intimated so late regarding purchase of the aforementioned car since his father was suffering from paralysis since 2010 & had passed away in 2021. The officer had to take care of him for which he was unable to sent the information on time.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Kaushambi also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Kaushambi for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
