May kindly see the online application of Sri Ankit Kumar Mittal, Additional District & Sessions Judge (FTC), Meerut regarding information regarding sale of his old Maruti 'Alto 800 LX car', intimated through his application dated 14.12.2021.

Through his application, Sri Ankit Kumar Mittal has stated that he has sold and delivered his old car on 25-08-2021 named 'ALTO 800 LX' having reg. no. UP11AR 8042 to a reputed seller named as Girmarsoft Automobiles Pvt. Ltd. also known as Car Dekho. The total price received by him for that car is Rs. 1,38,500/-. Sale amount received by him Rs. 1,38,500/- in his saving bank account Central Bank of India, Branch Muzaffarnagar. (Copy of Vehicle Details Form, Payment Mandate Letter, Vehicle Delivery Confirmation Note issued by the said purchaser and Bank Statement of the officer can be seen as attachment). The officer has therefore, intimated about the sale of his old car for kind perusal of this Hon'ble Court.

In this connection, it is submitted that the officer has purchased the car in the year 2015 i.e. before his joining of Judicial Service. Source of amount spent on purchasing said car was from his professional income as Lawyer. He has also informed about said car to the Hon'ble Court in his first property statement Case ID 2331, which has already been approved by the Hon'ble Court. Thus, as he has sold the car through a regular and reputed dealer, there seems to be nothing objectionable as per the Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956, which is as follows:-

24 (2):- *"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;*

*Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."*

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Meerut also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Meerut, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
