It is noteworthy to mention here that the officer has been asked to clarify as to why he has purchased the plot from a private person namely Smt. Vandana Gangwar & Sri Vivek Gangwar R/o 195, Professor colony, Badaun, without obtaining prior permission of the Hon'ble Court and thus violated the provisions of Rule 24 (1) of U.P. Government Servant's Conduct Rules 1956. In reply, the officer has submitted that at the time of purchase of the said property he was new in service and was ignorant of the said rules. He will remain vigilant in the future and will not repeat the same. He has tendered his unconditional apology for the same and has requested to consider his matter for which he remain obliged. Violation of Rule 24(1) of U.P. Government Servant's Conduct Rules 1956, caused by him, under the above mentioned circumstances, is highly regretted for which he has tendered his unconditional apology.

As such, the matter is now upto the discretion of Hon'ble Court either to accept the information submitted by the officer to regularize the matter or to pass any other order, which His Lordship deems fit and proper.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Meerut, for His Lordship's kind perusal & order for acceptance of information about purchase of residential plot no. E-69, measuring area 149.58 sq.mtr., Khasra No.16, International City, Mid-town, Nariyawal, Bareilly by Sri Anurag Singh, Civil Judge (Senior Division), Meerut?
